- a. Proposed High School Graduation Requirements, 9th-12th Grades, R127-03-04.
 - proposal would eliminate Regional Studies and Health as specific course requirements. The Board is requested to approve the recommendation for proposed changes to graduation requirements.
 - b. *Resolution 17-03-04 Los Angeles County Schools Pooled Tax and Revenue Anticipation Notes (TRANS) Program. Tax and Revenue Anticipation Notes (TRANS) are short term, tax exempt securities which are issued by public agencies to provide adequate funds for expenditure during periods of projected cash short falls. The TRANS must be authorized by resolution of the Governing Board as directed by Government Code Section 53580. The Board is requested to approve Resolution #17-03-04: Los Angeles County Schools Pooled Tax and Revenue Anticipation Notes.
 - c. *Resolution 18-03-04 Intention to Issue Tax Exempt Obligations. Prior to the issuance of the \$25 million bonds, it may be advantageous to the District to incur certain capital expenditures from available moneys of the District. Those funds to be advanced to pay the expenditures will be available only for a temporary period and will be reimbursed to the District from the proceeds of the bonds. It is requested the governing board approve Resolution 18-03-04 authorizing reimbursement of Bond Funds.
 - d. Approve School Calendar for 2004-05, R130-03-04. The governing board is requested to approve the proposed school calendar for 2004-05.
 - e. Elimination of Bus Service to and from Chilao, R88-03-04. Since the closing of the school at Chilao, the District has provided bus service to and from school for those students living at Chilao. Due to the need to reduce expenses it is requested the governing board approve elimination of bus service for students to and from Chilao for the 2004-05 school year.
