- 1. <u>First Reading</u> [Asterisk (*) denotes action may be taken on the first reading.]
 - a. 2004-2005 Proposed Budget, R162-03-04. The presented 2004-05 Proposed Budget reflects the most recent information on the Governor's Proposed Budget as well as local modifications, revisions and plans for next year. The Board is requested to approve the board policy revisions.
 - b. *Resolution #28 Temporary Cash Transfer and Resolution #29: Temporary Borrowing. To protect districts against temporary cash shortages, the Los Angeles County Office of Education makes cash available to districts with no interest or other charges. The Board is requested to approve Resolution #28 Temporary Cash Transfer and Resolution #29 Temporary Borrowing.
 - c. *Declaration of Need for Fully Qualified Teachers, R157-03-04. LCUSD anticipates that it may need to employ some teachers who are in the process of completing a full credential.
