- New Board Policy 6191 Consolidated Program Evaluation, R124-00-01. As established by the Instructional Planning Group and the Leadership Support Team in 1997-98, the district's multiple measures assess the progress of all students in achieving grade level expectations. Those multiple measures are the criteria by which program effectiveness is explicitly measured. The criteria and the evaluation process constitute the basis of Board Policy 6191. Board Policy 6191 is presented for first reading.
- e. \*English Language Acquisition Program Grant Application, R125-00-01. The English Language Acquisition Program (ELAP) was signed by Governor Davis on July 6, 1999, and became effective on January 1, 2000. Funding still remains for 2000-2001.
