- 1. <u>First Reading</u> [Asterisk (*) denotes action may be taken on the first reading.]
 - a. *Resolution #15-02-03 Classified Layoff. La Cañada Unified School District has determined that there is a lack of work or lack of funds to maintain the positions of Paraprofessional I, II, Campus Aides, Elementary and High School Health Office Coordinators, Textbook Coordinator, High School Security, Fine Arts Specialist Music, Auditorium Technician and Office Assistant II. The Board is requested to approve Resolution #15-02-03 Classified Layoff.
 - b. *CSBA Delegate Assembly Election Ballot, R144-02-03. Annually, members of California governing boards elect members to the California School Boards Association (CSBA) Delegate Assembly. There are currently two vacancies in sub-region 23-A. The Board is requested to instruct the president as to how to mark the ballot for the CSBA Delegate Assembly Election.
 - c. *Rental Fees for IRC, R145-02-03. Since the opening of the LCHS IRC, many community groups have requested the use of space at the IRC. Currently the IRC is not being rented to the community. The District would like to set the rental rate at \$50.00 for Community Users and \$25.00 for Non-Profit Users. The Board is requested to approve the Rental Fees for IRC.

- a. Educational Goals for 2003-04, R135-02-03. These revisions were initially suggested by the Curriculum Council on January 16, 2003. If approved by the Board, all sites will use this statement of goals as the basis of their site planning. This item is presented for first reading.
