April 24, 2001 GOVERNING BOARD MEETING, DESCRIPTION OF ACTION ITEMS

1. <u>First Reading[Asterisk (*) denotes action may be taken on the first reading.]</u>

- a. *Local Improvement Plan Revisions, R218-00-01. The LCUSD Local Improvement Plan consists of both district and site level action plans as well as detailed explanation of programs/projects in the seven areas of curriculum planning and implementation; teaching/learning process; standards, assessment, accountability; student services; staff development/professional growth; governance and administration; school/parent/community involvement. The purpose of this revision is to specifically relate and align activities in the seven areas to the overall district goals. The Board is requested to approve the revision of the Local Improvement Plan.
- b. *API Spending Plans, R216-00-01. Senate Bill 1 (Chapter 3, Statutes of 1999) provides for financial awards to schools whose Academic Performance Index scores meet state targets. One category of those awards is the Governor's Performance Awards (GPA). La Cañada Elementary, Paradise Canyon Elementary, Palm Crest Elementary and La Cañada High School all qualify for the GPA money. Upon approval by the local School Site Council, GPA spending plans are submitted to the Governing Board for approval, as mandated by legislation. The Board is requested to approve the three School Site Councils' Governor's Performance Awards spending plans as submitted.
- c. *Approval of CEC Child Care Proposal, R219-00-01. In February 2001, after considering whether to provide its own district-operated child care services, the District formally posted a Request for Proposal in area newspapers. The Child Care Roundtable (augmented by the participation of all three elementary principals) thoroughly reviewed, scored and discussed the two proposals received. The unanimous consensus of the Child Care Roundtable is to accept the proposal of the Child Education Center (CEC). The Board is requested to approve the CEC Child Care Proposal.
- d. *Deferred Maintenance Plan, R206-00-01. The 5-year Deferred Maintenance Plan reflects maintenance needs on projects in the State School Deferred Maintenance Program. This Deferred Maintenance Plan reflects changes and updates to the plan. The Board is requested to approve the Deferred Maintenance Plan.
- e. *Approval of Agreement with YMCA for Use of School Property for 2001 Summer Day Camp, R211-00-01. The Crescenta-Canada YMCA has submitted a request for use of District property for its 2001 Summer Day Camp, for the period commencing June 21, 2001 and ending August 27, 2001. The Board is requested to approve the Agreement for Granting Use of School Property to the Crescenta-Canada YMCA for its 2001 Summer Day Camp.
- f. Authorization to Enter into Contract with Architect for Modernization, R212-00-01. Fundraising has been completed to build an outdoor science laboratory at LCE. HMC Architects have prepared plans for the project scheduled to begin in June 2001. The Board is requested to authorize adding HMC to the district's list of approved architects and authorize staff to enter into a contract with HMC on an as-needed basis.
- g. *Request to Go to Bid for Elementary Projects, R213-00-01. The timeline for the first phases of work will begin this summer. A portion of the projects (50%) must be bid and contracted for within 18 months of the approved funding application. The Board is requested to approve going to bid for the elementary modernization projects.
