1. First Reading[Asterisk (*) denotes action may be taken on the first reading.]

- a. Approval of 2001-2002 Proposed Budget, R248-00-01. The attached 2000-01 Estimated Actuals is the best estimate of the District's position as of June 30, 2001. The attached 2001-2002 Proposed Budget reflects the most recent information on the Governor's Proposed Budget as well as local modifications, revisions, and plans for next year. This is being presented for first reading only.
- b. *Board Policy 1330 Revisions, R253-00-01. The District has recently revised the Short Term Facility Use Procedures and Facility Use Rates. Therefore, minor adjustments have been made to the Use of School Facilities Board Policy BP 1330 (a) to reflect the changes. The Board is requested to approve Board Policy Revision BP 1330 (a).
- c. *Supplemental Amendment to Joint Use Agreement Skateboard Park, R264-00-01.
- d. *ASB Budget 7/8, R249-00-01. The incoming ASB plans and approves their fiscal budget every year. This procedure sets guidelines for how much money is available toward allowable expenditures. The data provided is based on prior year revenues and expenditures and anticipated current year revenues and expenditures. The Board is requested to approve the ASB Budget for 7/8.
- e. *ASB Budget 9-12, R250-00-01. The incoming ASB plans and approved their fiscal budget every year. This procedure sets guidelines for how much money is available toward allowable expenditures. The data provided is based on prior year revenues and expenditures and anticipated current year revenues and expenditures. The Board is requested to approve the ASB Budget for 9-12.
- f. 2001-2002 District Educational Goals, R259-00-01. The Curriculum Council generated K-12 District educational goals that serve as the basis for program planning, implementation and review. These revisions were suggested by the Curriculum Council on May 15, 2001. The Board is requested to approve the 2001-2002 District Educational Goals.
- g. English Elective Proposals 2001-2002, R260-00-01. English elective choices include various titles beyond the core reading list. The English ¾ and Advanced Placement English teachers are requesting approval of elective titles. The Board is requested to approve the English Elective Proposals for 2001-2002.
- h. *Declaration of Need for Fully Qualified Educators, R247-00-01. The California Commission on Teacher Credentialing requires that prior to application for emergency permits, a Declaration of Need for Fully Qualified Educators must be on file in Sacramento. La Cañada Unified anticipates that it may need to employ some teachers in Special Education, Physical Education, Spanish, Science, Math and Elementary classroom positions who are in the process of completing a full credential. This Declaration is for the 2001-02 school year only and must be filed with the CCTC prior to any initial or renewal applications for emergency permits. The Board is requested to approve the Declaration of Need for Fully Qualified Educators.
- i. *Approve CSEA 2001-02 Calendar, R255-00-01. The school work calendar is an item that must be negotiated with the appropriate Bargaining Unit. Recently CSEA and the District negotiating team agreed on a proposed work calendar for the 2001-02 school year. The Board is requested to approve the 2001-02 CSEA School Calendar.
- *Resolution #24-00-01 To Limit Candidate Statements to 200 Maximum Words. Pursuant to Education Code Section 5000, elections will be held on November 6, 2001, to elect members to governing boards in most L.A. County school districts. There will be three seats on the La Cañada Unified School District Governing Board up for election at that time. In the past La Cañada Unified has passed a resolution limiting the number of words in candidate statements. Again, candidates are asked to limit their statements to two hundred words or less, with payment of the maximum estimated cost for such statements to be made
