July 17, 2001 GOVERNING BOARD MEETING, DESCRIPTION OF ACTION ITEMS

1. <u>First Reading[Asterisk (*) denotes action may be taken on the first reading.]</u>

- a. *Resolution #2-01-02 Grades 9-12 Assurances for Fiscal Year 2001-02 Pupil Textbook and Instruction Materials Incentive Program. Education Code 60451 requires that "Schiff-Bustamante" funds for pupils in grades 9-12 be used for purchases of instructional materials aligned with content standards adopted by the State Board of Education. The following 9-12 texts have been determined by staff to align with the California History-Social Science standards: *Economics Principles in Action*, and *World Cultures*, *A Global Mosaic*. The Board is requested to approve Resolution #2-01-02 Grades 9-12 Assurances for Fiscal Year 2001-2002 Pupil Textbook and Instruction Materials Incentive Program.
- b. *Textbook Adoption: World Cultures, A Global Mosaic, R21-01-02. The high school has a long tradition of wanting students to become informed global citizens who appreciate diverse cultures. Regional Studies enables students to become aware of China, Latin America and the Middle East and their importance to the global society. This goal is best achieved by World Cultures A Global Mosaic, published by Prentice-Hall. The Board is requested to approve adoption of textbook: World Cultures A Global Mosaic.
- c. *Textbook Adoption: *Economics Principles in Action*, R22-01-02. The current economics textbook is over five years old and out-dated. The social science department has chosen *Economics Principles in Action*, published by Prentice-Hall, as the preferred text. The Board is requested to approve adoption of textbook: *Economics Principles in Action*.
- d. *Change Date of Board Meeting from October 2 to October 1, 2001, R3-01-02. The Board is requested to approve the change of meeting date from October 2 to October 1, 2001, so as not to conflict with the high school Back to School Night previously scheduled.
- e. *Resolution #1-01-02 Implement IRC Section 125 Flexible Fringe Benefits Plan. The district has negotiated with the La Cañada Teachers Association for the implementation of an IRC Section 125 Flexible Benefits Plan. This plan allows employees to direct a part of their pay, on a pre-tax basis, into special accounts that can be used throughout the year for reimbursement of certain out-of-pocket medical, dental and/or dependent day care expenses. The Board is requested to approve adoption of Resolution #1-01-02 Internal Revenue Code (IRC) Section 125 Flexible Fringe Benefits Plan.
- f. *District Base Allocation for School Clerical and Aides, R15-01-02. The district has developed an allocation plan for the assignment of clerical and aide time to school sites. In developing this plan, a CASBO recommendation for staffing was considered along with the special needs of La Cañada. The Board is requested to approve the District Base Allocation for school clerical and aides.
